Section 4 First Aid Measures

Section 7 Handling and Storage

Handling and Storage Precautions: Avoid heat, open flames, including pilot lights, and strong oxidizing agents. Use general ventilation to prevent vapor accumulation. Have appropriate fire extinguishers and spill clean-up equipment in or near storage area.
